The company was listed in 2017 on the Euronext Growth Milan (EGM) market of Borsa Italiana. In 2023, it delisted from Euronext Growth Milan (EGM) following the entry of the investment fund Three Hills Capital Partners into the company's shareholding structure.

Digital360 closed 2024 with revenues of 124 million euros.

Headquartered in Italy, in Milan and Rome, it operates in 8 countries with 1,245 people.
