DIGITAL360 concludes 2022 with sixth acquisition in Latam. 100% of the shares of the company Ycon in Argentina acquired

Milan, 30 December 2022 - **DIGITAL360 S.p.A.**, a Benefit Company ("DIGITAL360" or the "Company"), an innovative SME listed on the Euronext Growth Milan market, announces that it has completed the acquisition of 100% of the shares of the company Ycon SAS ("**Ycon**") based in Buenos Aires and its US subsidiary Textualists LLC, based in Albuquerqe (New Mexico).

With this further acquisition, the sixth finalised during 2022 in the Latin American region, the Group continues its successful journey to become the reference point for supporting the world's leading technology companies in their marketing and lead generation activities in Spanish-speaking countries.

Ycon, based in Buenos Aires, is a company specialising in the production of high-quality editorial content and communication campaigns and supports its B2B clients in improving their image and commercial positioning in the target market.

The acquisition of Ycon follows in Argentina that of Xona, a marketing agency specialising in the B2B market and technology companies, which was finalised this same month: DIGITAL360 thus aims to replicate in the LATAM area (after Mexico and Colombia) the business model successfully developed in Italy, which involves combining digital publishing assets with B2B marketing activities as well as technology platforms from Martech and Salestech.

Ycon currently has a turnover of approximately EUR 0.15 million.

The agreement provides for the purchase of 100% of the shares for a consideration of USD 130,000, to which an *earn-out* component may be added based on the achievement of certain economic results expected for the years 2023 and 2024.

Among other stipulations, the agreement specifies entrepreneur Pedro Ylarri will continue as manager for at least four years after the acquisition. This is in continuity with the current management and following a consolidated and successfully tested acquisition model to date.

"Ycon's entry into the Group represents the sixth operation in 2022 in the region. We are convinced that the achievable synergies and the complementary nature of DIGITAL360's acquisitions in Latin America will quickly have a multiplier effect and will enable us to become the leader in B2B marketing in the ICT sector in the region in the near future, a reference point for innovation and a glocal partner for the big global players in the segment," says **Simone Battiferri**, Head of LATAM at DIGITAL360. "We warmly welcome Pedro to the team".
